Ä	Combustable waste:	Waste for incineration. Can not contain any of the categories below without agreement.
	Alumium, steel and tin cans:	Metal packaging includes all food and beverage packaging made of metal. Without plastic bag.
	Metal:	Scrapmetal. All types of metal other than metal packaging. <b>Not food cans</b> .
V V	Bottles and Glass iars:	Glass packaging is glass that is used for storing food and beverages. Without plastic bag.
	Cardboard:	Cardboard packaging where at least one of the layers in the cardboard is a "wave".  Clean and dry.
A	Dangerous waste:	Oily rags/waste/filters,spay can, flourescent light, etc. No leakage.
Ì	Food Waste:	For example: meat, fish, dairy products, beer and mineral water, fruits and vegetables baked goods.
*	Electrical waste:	All products that run on electricity or batteries are considered EE-waste when they are to be disposed of.
11	Waste wood:	Pure wood is wood that is free of larger metal parts. Wooden pallets are accepted here.
Ā	Plastic:	All types of soft plastic.
Ō	Medical waste:	Infectious waste is waste from medical treatment.
222	Cooking oil:	Cooking oil / frying oil must be delivered in <u>sealed</u> containers separately from other waste

- · Fizzy drink/beer cans
- · Tin cans

Should be emptied and rinsed out.



#### CARDBOARD

- · Cardboard packaging
- · Brown corrugated cardboard



#### PAPER

- Newspapers
- Magazines
- · Copying paper
- Envelopes



# HAZARDOUS WASTE

- Paint
- Solvents
- Batteries
- · Fluorescent tubes and bulbs
- · Oil and oil filters
- · Aerosol cans
- · Pressure-treated wood
- · Gas canisters
- · Fire extinguishers

- · White goods

- · Untreated wood
- · Pallets
- · Chipboard
- · Roofing sheets
- · Painted wood



# NON-COMBUSTIBLE WASTE

- · Porcelain/stoneware
- Plaster
- Concrete
- Tiles

- · Fire resistant glass



# COMBUSTIBLE WASTE
